Shea Homes Update

Our HOA Board was recently notified of a current update to the new Shea Homes being built north of the Fire Station. Updates have been few since our March 2025 HOA meeting.

After receiving the notice, HOA President Ken Colaizzi spoke with the planner/engineer of the project. In summary, this is just a formality from Jefferson County explaining the Intergovernmental Agreement (IGA) and the Comprehensive Development Plan (CDP). This article will bullet point some facts and squash some rumors after reviewing the posted Jefferson County Notice.

Facts:

- Shea Homes owns this mentioned property.
- Shea Homes intends to build 27 to 30 homes on this property (map shows 27 homes).
- Shea Homes can't start building until they have a green light from Jefferson County and the City of Littleton.
- Once built, these homes will be part of the TrailMark HOA and will be assessed quarterly.
- These additional homes will also be taxed annually by the TrailMark Metro District.
- This process will still highlight the ever mentioned "View Corridor."
- Chatfield Activity Center was the name of this lot when Shea was first developing back in the early 2000's (part of legal application).
- Currently there are 799 homes in TrailMark (this includes 659 single family, 68 patio homes, and 72 condos).
- After this build, there will be approximately 826 to 829 total homes in TrailMark.
- The 876 mentioned homes is a TOTAL number that the City of Littleton and Jefferson County cooperatively agreed to cap as the amount of homes in ALL of TrailMark to preserve our community. (The city and county suggest a cushioned number to the builder setting a maximum amount of homes in the entire neighborhood there are no other builders who own land in TrailMark, so an additional 47 to 50 homes is highly unlikely).
- Shea will not entertain any other monetary offers because they are building homes on this lot.
- The proposed preliminary site plan is part of the application and is a draft at this time, not final.
- Public comments to Jefferson County are due to Sara Kohles by Monday, August 18, 2025 (contact info below).

Rumors put to rest:

- The TrailMark HOA doesn't own this lot.
- The TrailMark Metro District doesn't own this lot.
- Chatfield Activity Center doesn't mean Rec Center or Activity Center (it was the original named piece of land by Shea).
- Shea is not building an activity/community center on this lot.
- Shea is not building a pool on this lot.
- Shea is not building a rec center on this lot.
- According to Jefferson County and the City of Littleton, 76 homes cannot and will not fit on this lot.

Surrounding this mentioned property, you will see three (3) posted yellow signs informing the community of the application process for Shea to build these homes. We are also publishing the proposed "Preliminary Site Plan" which is part of this Jefferson County application. You will notice on this map there are 27 planned new homes. The new planned view corridors which are part of this IGA are also marked on this map.

Our HOA Board will continue to publish any and all notices that we receive so our residents can be thoroughly informed. We are trying to get one of the planners of these homes to attend our September or November HOA meeting so some of you can ask questions in person. Scheduling is still in the works, but please watch our posted agendas on trailmark.org, and we will also post an article if one of the planners confirms to meet during one of our HOA meetings with a new update.

HOA Board of Directors Calling for Candidates

Each year our HOA Board of Directors has an annual election. This coming
November, there will be two (2) HOA Board of Director positions up for election.
Currently, the seats of President Ken Colaizzi and Vice President Arwen
Vaughan are up for election. Ken and Arwen do have the option of filling out a Self-Nomination Form a

Vaughan are up for election. Ken and Arwen do have the option of filling out a Self-Nomination Form and running for another two-year term.

The terms for Tonya Sloan (Secretary), Phil Kinney (Treasurer) and Dave Soule (Member at Large) do not expire until November 2026.

SELF-NOMINATION FORM

All self-nomination forms are due to Westwind Management by end of the day September 12th, 2025. Turning in your self-nomination form by September 12th will guarantee that your candidate platform will be included in the Annual Meeting mail-out in October as well as your name being on the HOA Board of Directors ballot.

Our Bylaws also permit residents to nominate themselves at the Annual meeting, pursuant to meeting the noted qualifications.

TrailMark's Second Amended Bylaws, posted on TrailMark.org, clearly define the Qualifications of Directors in section 5.3:

"A director may be re-elected and there shall be no limit on the number of terms a Director may serve. In order to be eligible for election and/or appointment to the Board of Directors, an Owner must be in good standing with the Association. Good standing means, without limitation, free from any outstanding balance owed to the Association and free from any infractions with the Association."

If you are elected, you will participate in 6 bi-monthly HOA meetings (usually two hours long), as well as 5 bi-monthly work sessions at Westwind Management. You will also help with various committee events. All positions are volunteer and usually consume about 2-5 hours a week with emails and/or phone calls amongst Board Members, the management company, vendors, committee members and homeowners.

Once the votes have been certified and counted at the Annual HOA meeting on November 11th, the Board will then have a brief meeting to decide who will be President, Vice President, Secretary, Treasurer, and Member at Large for 2025-2026.

Being an HOA Board member is rewarding as you are able to assist your neighborhood with enforcing its covenants, aiding in the beautification of our neighborhood, assisting fellow neighbors to follow the HOA process, and helping maintain our property values.

If you meet the above criteria, and can dedicate your time to TrailMark, then we strongly encourage you to complete your self-nomination form and run for the TrailMark HOA Board of Directors.

Drivers: Reminder to Stop when School Bus Lights are Flashing

As we start a new school year, we would like to remind residents that when the school bus lights are flashing **RED**, drivers must stop from every direction.

Colorado law states: "You must stop your vehicle at least 20 feet before reaching a school bus that is stopped with its red lights flashing whether it is on your side of the road, the opposite side of the road, or at an intersection you are approaching. You must remain stopped until the flashing red lights are no longer operating. Watch carefully for children near the school bus and children crossing the roadway before proceeding."



Wildfire in Jefferson County is always a concern

Due to Jefferson County's geographic makeup, wildfire is always a concern, and it is a more potent threat during droughts or dry spells. Rainfall and cooler temperatures may reduce the danger of wildfire; however, people are encouraged to be vigilant as the danger of fire is always present in the high country. The risk is even greater when under a fire weather watch or red flag warning. Citizens should use caution when starting and extinguishing campfires, disposing of lighted cigarettes, and other activities that involve the use of fire or sparks.


