Or how to use the Jaws of Life to save someone from a car crash? Or how investigators find the causes of fires? Or how dispatchers direct resources to emergencies?

We at South Metro Fire Rescue invite you to participate in our annual Citizens Academy. This 9-week academy is a rare opportunity to discover the mysteries of modern firefighting and learn priceless life-saving skills. You'll learn about South Metro Fire Rescue from behind-the-scenes, and learn about yourself and your community in the process.

Each of the nine classes is taught or facilitated by SMFR personnel. The schedule of classes is attached, but it is subject to change if restrictions are needed in response to COVID. Each class lasts from 6-10 p.m. Locations vary depending on the topic. Attendance is critical to your success in the program; participants are expected to attend every class. Participants are asked to perform physically-challenging activities such as rappelling, crawling, and performing CPR on mannikins. While we won't exclude candidates based on physical abilities, we want to be transparent about the nature of the activities.

This program is open to adults aged 18 and older who live in or work in our jurisdiction. As pledged, you are receiving this invitation in advance of the general public, but receiving it in advance does not guarantee you a position in this year's academy. It gives you a few more points for enthusiasm in our eyes, but we'll still weigh your application against all the others that are submitted.
