We apologize for the incorrect letter that was included with your quarterly payment coupons. The HOA's management company used a service that inadvertently mixed up coupons for two of their similar sounding associations. The account information on the coupons is accurate. Owners should ignore the dates on the coupons and submit \$96 quarterly as they normally would, with dues dates on 1/1/16, 4/1/16, 7/1/16, and 10/1/16.

Pursuant to the Association's governing documents, the <u>quarterly</u> assessment for 2016 will remain the same rate of \$96.00.

- Credit Card Payments: Visa® Card, MasterCard®, Discover®, and American Express® are accepted for one-time assessment payments (banking fees may apply).

- Allow up to 7-10 business days for processing if you choose to use this payment method.
- Include the NEW account number found on your coupons with your payment.
