FINANCIAL ITEMS

Public Hearing to Adopt 2011 Budget and Appropriate Expenditures: Director Rogers opened the Public Hearing at 7:40 p.m. Ms. Noon presented the proposed budget which included the three mill levy options under consideration by the Board. The Board answered questions from the public and, following consensus from the public on the budget option with a mill levy of 35 mills, closed the public hearing at 8:24 p.m. Final approval of the budget will be held at the December 14, 2010 special meeting.

OTHER BUSINESS

<u>Public Comments</u> – The Board answered questions and provided updates as follows:

- It was noted that the community center/pool project has been canceled at this time;
- In regard to trash collection being handled by the District versus the HOA, the Board decided not to proceed following legal opinion stating trash collection was not a clear option for the District;
- The by-laws committee noted they are still reviewing other district examples prior to implementation;
- It was noted that the District has no action planned regarding the commercial property owned by Shea at the entrance to TrailMark
