ROUND-UP

The TrailMark Homeowner's Association met on Thursday, July 9th at the Daycare Center, for their regularly scheduled meeting. Here are some of the issues which were addressed:

Unightly vehicles: We received some information from our attorney and the City of Littleton regarding this issue:

Regarding derelict or unlicensed vehicles, the City of Littleton cites Littleton City Code 7-4-9. "It shall be unlawful for any person to store, maintain or keep, any "derelict vehicle,"on any private property or adjacent public right of way in the city; and it shall be unlawful for any owner or manager of real property to permit or allow the storage, maintenance, or keeping of any such derelict vehicle or unlicensed vehicle on real property under their dominion or control." The Board instructed the Covenants Committee and Hammersmith to report any derelict or unlicensed vehicles to the City of Littleton. We continue to work on this "car" problem, in order to maintain the beauty of our neighborhoods.

Newsletter: Because of the greatly increased cost of formatting the newsletter, the Board has determined that we can no longer support a newsletter of 24 – 32 pages. We have decided to limit the newsletter to a consistent 16 pages. This will not affect the articles, but will affect the amount of advertising that we can carry, as well as additional pictures, etc.

At previous homeowner's meetings, we have asked for a show of hands of those homeowners who would be willing to receive the newsletter electronically. In order to know how many people would prefer this method, we are asking those neighbors who prefer to receive the newsletter via e-mail, to e-mail your request to communications@trailmarkhoa.org. Please include your name, e-mail address and a contact number. As more neighbors request this paperless newsletter, we will then be able to reduce printing and mailing expense.

Larry Vickerman, from Denver Botanic Gardens at Chatfield, visited the meeting to let neighbors know about the two concerts that they have planned for this August. Chris Isack will be appearing on August 16th and The Pretenders will be appearing on August 22. Check the DBG at Chatfield website, botanicgardens.org, for times and prices. It should be great fun.

Legal answers were received from the HOA's attorney concerning the upcoming TMMD Community Center and Clubhouse: The Board asked that 4 questions be addressed:

- (1) What general latitude does the TrailMark Metro District (TMMD) have in spending the tax dollars or special assessments as contributed by the homeowners of TrailMark?
- (2) Are any Colorado statutes violated or in conflict by the TMMD managing and financing the design and construction of a clubhouse/pool? ... Specifically, SSPR already provides similar servicesDoes this dual service violate any premise of or is this deemed ... "dual taxation?"
- (3) What is the responsibility of the HOA to the community of TrailMark in providing oversight of the actions taken by the TMMD?
- (4) Does the HOA's Design and Review Committee have the authority to require approval of properties that do not pay taxes? Please read the answers to those questions posted on the trailmarkhoa.org website.

Budget for 2010: Costs for trash removal, newsletter, social, management, postage, landscape, water and sewage and the Covenant Patrol have pushed our budget over its projections. The Board is researching a variety of ways to cut costs wherever possible, as we re-negotiate contracts and begin the budget planning process. There is also the probability that an increase in association fees may be necessary. If a fee increase is necessary, it will be the first time since TrailMark was established, that an increase has been effected.

Further discussion on these and other issues will occur at the next meeting on September 10th. Homeowners are always encouraged to attend meetings.

IMPORTANT NEWS FROM TrailMark Metropolitan District (TMMD)

The new TMMD Website is up and running!

Yes, the TrailMark Metro District now has its own website. Please check it out! The web address is: www.tmmd.org. Neighbors who visit the website can view meeting agendas, district maps, the Metro District's Service Plan, history of the TrailMark Metro District, and a section is planned for future questions regarding the Community Center and Pool Project. Bob Chavez, TMMD Board Member, started the website for the District and will continue to update.

Meetings and Times

The TMMD is planning to meet more often due to the work that is involved in the mandate that was given to the Metro District; that of, building a Community Center and Pool. **The District will meet once a month, at least, on the third Tuesday of the month.** There may be more Special Meetings called as needed to fulfill deadlines that might be given the TMMD by the City of Littleton, SSPR or the Design Team when they have been hired. Check the Community Bulletin Boards at Hogback Hill and TrailMark Park for dates and times. The website will also list the next meetings of the TMMD.

What has gone on since the vote?

1. The TMMD met shortly after the vote of the community and officially voted to begin the process to build and fund the Community Center and Pool.
2. The TMMD advertised for RFP's (Requests for Proposals) for Design Teams.
3. The TMMD submitted the Development Plan to South Suburban Parks and Recreation (SSPR) for their approval as required by the Intergovernmental Agreement between TMMD and SSPR regarding the building of the Community Center and Pool in TrailMark.
4. The TMMD received 14 RFP's. A consultant was hired to review the proposals; explain the packets; provide summaries; and give the TMMD Board the information necessary to make an informed decision to interview companies.
5. The TMMD decided to interview 3 companies.

Little-known Fact:

It was 10 years ago in August that the [first TrailMark neighbors](#) moved into their home.

The Board held a regular meeting on July 6, 2009. No new business was brought up. The painting of three (3) buildings was accomplished earlier this summer and the areas of Freiburg Drive which needed to be repaved have been done.

The Board wishes to thank those homeowners who have changed from white bags to black for their trash, in order to discourage the birds (particularly those big black crows) from tearing the bags open and spreading trash around. Also, please place your trash bags/cans on the street immediately adjacent to the curb. **Do not place them on the grass** as that damages the grass, as well as interfering with the sprinklers.

Landscaping Committee:

The landscape committee has been very vigilant this summer, turning off the sprinklers when we had some wonderful afternoon showers – to conserve water. The committee continues to replace trees as our budget allows. Some have been replaced already this summer, with “several more” to follow. As well as trees, additional shrubs have been planted in various common areas.

The landscape committee urges every homeowner who drives and parks on Freiburg Drive to avoid driving/parking over the edge of our rounded curb. That immediate area contains the sprinkler heads for our irrigation system, and cars which run over the sprinkler heads cause damage both to the heads and landscaping. Also, please refrain from parking over the entrance to sidewalks, as these need to be handicapped accessible.

Our grass and bushes have never been in better shape at this time of year. With the additional moisture that we have received, and some maturity, we are beginning to look like a more established area.

When you have a chance, give Betty McGinnis a “well-done” as she has been the liaison to Rocky Mountain Custom landscapes in being pro-active in keeping our landscaping in such good shape.
